

# BondiGroup Ltd. Privacy Policy

At BondiGroup Ltd., we are committed to maintaining the trust and confidence of customers and visitors to our web site. In particular, we want you to know that BondiGroup is not in the business of selling, renting or trading email lists with other companies and businesses for marketing purposes. In this Privacy Policy, we've provided information on when and why we collect your personal information, how we use it, the limited conditions under which we may disclose it to others and how we keep it secure.

## Types of data we collect

### Cookies

Our websites use cookies to collect information. This includes information about browsing by people who access our website.

### Google Analytics

When someone visits [www.bondigroup.ie](http://www.bondigroup.ie) we use a third party service, Google Analytics, to collect standard internet log information and details of visitor behaviour patterns. We do this to find out things such as the number of visitors to the various parts of the site. This information is only processed in a way which does not identify anyone. We do not make, and do not allow Google to make, any attempt to find out the identities of those visiting our website.

### Other Data

We may collect information such as contact details, computer information and subscriptions while providing you with service.

## Mailing Lists

As part of the registration process for our e-newsletter, we collect personal information. We use that information for a couple of reasons: to tell you about stuff you've asked us to tell you about; to contact you if we need to obtain or provide additional information; to check our records are right and to check every now and then that you're happy and satisfied. We don't rent or trade email lists with other organisations and businesses.

## Third Parties

BondiGroup Ltd. may on occasions pass your personal information to partner organisations exclusively to process work on its behalf. BondiGroup Ltd. requires these parties to agree to process this information based on our instructions and requirements consistent with this Privacy Notice and GDPR.

## Securing your Data

BondiGroup Ltd. takes technical measures as well as organisational security measures to ensure that we protect your personal data from unauthorised access, use or disclosure.

BondiGroup Ltd. only partner with reputable service providers who contract to provide the same level of security on information so that your data is at all times protected and used in accordance with our Privacy Notice.

## Access to your personal information

You can request the following information:

- Identity and the contact details of the person or organisation (BondiGroup Ltd.) that has determined how and why to process your data.
- Contact details of the data protection officer, where applicable.
- The purpose of the processing as well as the legal basis for processing.
- The categories of personal data collected, stored and processed.
- Recipient(s) or categories of recipients that the data is disclosed to.
- Details of your rights to correct, erase, restrict or object to such processing.
- Information about your right to withdraw consent at any time.
- How to lodge a complaint with the supervisory authority (Data Protection Regulator).
- The source of personal data if it wasn't collected directly from you.
